## **Project Overview**

The VPs Accountability project funded by the Catholic Organization for Relief and Development Aid (CORDAID) is a one year project (October2013-September 2014) with an overall goal to strengthen the Nigeria CSO Coalition on Business and Human Rights to build and enforce measures of corporate accountability, including increasing state practices on business and human rights principles and standards and ensuring the Nigerian government and Oil companies commits to the Voluntary Principles on Security and

Human Rights. The major Objectives of the project are:

- To Increase the awareness of the VPs and provide a platform for engagement in Nigeria through trainings and workshops
- To enhance advocacy skills of community members and CSOs to persuade oil companies and the Federal Government to sign up to and operationalize the VPs.

# **Community** Awareness Sessions on the Voluntary Principles on Security and Human Rights (the VPs)

LITE Africa carried out an awareness session on the Voluntary Principles in Abagalada, Beneku, Koroama and Gbarantoruommunities in the two Niger Delta states: of Delta, and Bayelsa between March and April 2014, .

Communities choosen for this sensitization were oil producing communities with history of violence, conflict and rights violations.

Koroama and Gbarantoru in Yenagoa L.G.A of Bayelsa State are host communities to Shell Petroleum Development Company (SPDC). Abagalada and Beneku communities in Ndokwa West LGA of Delta state are host to Nigerian Agip Oil Company and Sterling Oil Company respectively.

These sessions provided a platform to create awareness and sensitize community members on the VPs as

a tool for dialogue and for them to advocate for the full implementation of the VPs by oil companies operating in their communities.

The Sessions had representatives of different socio-economic and political groups in the communities; including traditional leaders, women, youth leaders, elders, opinion leaders and retired Security Officers Women constituted about 30% of the total attendance in the communities.

As part of the effort in strengthening civil society efforts on the VPs advocacy, Cordaid is supporting two meetings of the Nigerian CSO Coalition on Business and Human Rights. A Meeting was held in Port Harcourt, Rivers State on the 15th of April 2013 with the aim to reinforce coordination of VP efforts across Nigeria.

It brought together 30 CSOs representatives working on issues of Human Rights, Peace and Conflict, transparency and accountability, corporate social responsibility and community development .

The meeting enabled participants to be sensitized on the VPs and various Business and Human Rights Framework and to develop an advocacy plan that will support the goal of the project, which is; ensuring the Nigerian government and oil companies commits to the Voluntary Principles on Security and Human Rights. LITE Africa facilitated the first Business and Human Rights Forum in the Niger Delta held on the May 14, 2014 in Port Harcourt, Rivers State. It bought together 27 stakeholders ranging from representatives of Shell Petroleum Development Company, Nigerian Agip Oil Company, Nigerian Police Force, National Human Rights Commission, Ministry of Justice, oil producing Community leaders from Delta, Rivers and Bayelsa states and Civil society Organizations working in the Niger Delta. The forum discussed on existing grievance mechanism and equipped participants with the 3rd pillar of the UN Guiding Principles on Business and Human Rights " Remedy Framework". The forum enabled stakeholders to be sensitized on their roles in advocating for corporate accountability standards in respecting human rights using the VPs most especially. At the end of the discussion, recommendations were proffered on ways to strengthen the grievance mechanisms and possibly establish it where it doesn't exist.
