# GENDER AND GOOD GOVERNANCE

#### **OVERVIEW**

Gender equality has never been central to good governance; rather it has been limited to conversations on human rights. However, gender and good governance have tremendous implications for development. Good governance is participatory, consensus oriented, accountable, transparent, responsive, effective and efficient, equitable and inclusive and follows the rule of law. It limits corruption and ensures that the views and voices of minorities and the most vulnerable in society are heard in decision making.

Integrating gender equality in good governance is key because women and men have different needs in terms of service delivery and policy. Where gender is not taken into account, budgetary allocations fail to acknowledge women's needs and fail to distribute resources evenly.

Including women in decision making structures ensures that their specific needs and concerns are heard. The FGDs on this topic revealed that only 24% of the FG's could identify a woman in government. In terms of community level governance respondents from all 20 communities were only able to identify 5% of female executives in their CDCs and only 37% of FGs believe that women should play a bigger role in community decision making. It is important to note that the ONLAG project makes a concerted effort to work with CDC and CT Chairmen to visit and revise community constitutions to mandate the reservation of 30% of positions for women and we have started to make progress in this area.

In Aviara Community, the Old Women's FG expressed that women are afraid to compete with men "in *almost everything in this community.*" Similar sentiments of male domination were also revealed in the Young Women's FG in Gbokoda, they expressed that, "*Men see themselves as all in all and have not allowed women to have a say which kill our morals.*" Despite this, 95% of participants noted that women should be included in decision making process. This reveals that support exists to enhance women's participation, if properly nurtured; women's inclusion can become a reality in many of these communities.

The exclusion of women in decision making in the surveyed communities extends to decisions on oil revenue allocation. Women's presence in Shell Petroleum Development Company (SPDC) and Chevron Nigeria Limited (CNL) sponsored Regional Development Councils (RDC) and Cluster Development Boards (CDB) is limited, in all the communities surveyed no more than four women were identified in each RDC or CDB and only 27% of focus groups stated that women contractors are allowed to bid for projects in the GMoU process.


In the 20 communities surveyed, women lack decision making ability, they are not proportionately represented in community decision making structures, nor are they adequately represented in the GMoU process. However, marginalization in decision making is not limited to women, both community men and community women are overlooked by government; 91% of FGs rated their relationship with state government as poor and similarly 93% rated their relationship with local government as poor. Not only do government representatives fail to meet the needs of the people they were elected to serve, they fail to maintain any form of communication with communities, 69% of respondents stated that they do not get information about budgetary allocations for development. Conversely, only 60% of FGs rated their relationship with oil companies as poor, this demonstrates that communities engage and communicate more regularly with oil companies and that oil companies are more accountable to them.

The FGDs further explored the relationship between communities and their elected representatives at the local level. In Idheze community the Young Men's FG made the following observation about elected officials: "once they are elected they abandon the people." In Aviara Community the Young Men's FG shared a similar sentiment noting that "government should pay more attention to the people and reduce their suffering."




Awareness of Channels for Constituency (Citizen) Assistance






